**ASSUMPTION OF RISKS**

- 3. **TO HOLD HARMLESS AND INDEMNIFY THE INSTITUTION FROM:**
  - a) any and all liability for any damage to the personal property of, or personal injury to, any third party resulting from my participation in the event and all related activities; and
  - b) any and all claims, demands, actions and costs which might arise out of my participating in the event even though such claims, demands, actions and costs may have been caused by the negligence of the Institution.
