3. Clarify requirements and description of wellness fund and student activities fund This will be reviewed by the student funding committee to provide clarification and reduce the long- term workload associated with funding claims.

4. Creating a healthy work-life balance It is important for my personal success to create this healthy balance in order to ensure I am doing my best duty as an executive, student, and person. I hope to do this by getting an initial feel for the position and adapting my workload accordingly.

5. Exploring more volunteer opportunities within the ASU Explore opportunities to partner with students to aid in the workload as well as foster an interest in the ASU from the ground up. This can be done by investigating different projects that may provide aid to the community as well as personal gain for the volunteers in the form of work-related experiences.
